Course Purpose:

This is a basic stage makeup class. It is designed to provide the future actor, designer, or theatre teacher the skills necessary to design and execute stage corrective and old age make-ups. In addition, the course will cover various commonly used special effects makeups for the stage.

Assessment of Learning Outcomes:

Assignments/Assessment of Intended Course Student Learning Outcomes

This is a skill development class and the student's grade will be based on their work in class and growth during the course of the semester. Students are expected to be fully prepared for and to participate in all class exercises, presentations and critiques. Students are expected to present their work as noted in the course outline (critique) and to develop their ability to self-critique. The student's learning and ability to apply the expected skills will be assessed by an on line quiz on all assigned readings, their creation of makeup research morgues on Pinterest, their creation and revision of makeup design face sheets, and their success in completing in-class skill development exercises. In addition, a midterm and final assessment of student learning will include a midterm and final design. All quizzes, learning exercises, and midterm and final projects are listed and due as noted in the course outline. **No late work will be accepted for credit.**

Course Policies:

Retests/Makeup tests/assignments

This class moves very quickly and because all the work is done in class there is minimal room for make-up days. Therefore, no late work will be accepted from unexcused absences. Nor will there be make-up days for unexcused absences. If a student misses a class, and has a documented excuse, then a new due date for that work will be assigned.

Attendance

Due to the very hands-on nature of this class, and the fact that the course grade is derived almost entirely from in class work, attendance is mandatory and students are expected to be in class and prepared to begin work on time. Unexcused absences and/or tardiness will have a severe negative impact on the final grade due to 5 points lost participation points for that day's course work/practice for an absence and 5 points lost points for a tardy (from the class participation grade). Emergencies, deaths in the family or severe illnesses must be accompanied by proper documentation in order to be excused (Please

contact the Office of Student Life for assistance). Students must provide an institutional form to the professor for Official University event absences. Students with six absences (6) TTh will fail the course.

"While class attendance is required per the above stated policy, please be cautious about attending class if you are feeling ill. Please inform me by phone or email if you are feeling unwell; if you are experiencing flu-like symptoms, you should not attend class; please take precautions not to infect others, and seek medical attention if your symptoms worsen".

If you have a fever you should not attend class, as you are infectious. If you are unable to attend class due to illness, you must contact me directly via email or phone call by the start time of class that day in order to makeup the test or hand in the work due that day.
